

AUTHOR AGREEMENT

In consideration for **The Permanente Federation (the “Federation”)** undertaking to publish an article tentatively entitled, “_____” (the “Work”) in **The Permanente Journal (the “Journal”)**, I hereby assign and transfer to **the Federation** any and all right, title, and interest, including all copyrights, in the Work, *e.g.*, without limitation, the right to obtain copyright registration, whether separately or as part of the Work or otherwise; the right to sue for past, present and future infringement of the Work; and the exclusive right to publish, reproduce, prepare derivative works of, distribute copies (itself or through distributors), by sale or otherwise, perform, translate, and display the Work, in whole or in part, in all forms and media worldwide, in all languages, if and when the Work is accepted for publication in the Journal.

I understand and acknowledge that the exclusive rights granted herein may be exercised by the Federation or its publication services provider, currently **The Sheridan Group** (“the Publication Services Provider”), acting at the direction of the Federation. In addition, I assign and grant to **the Federation**, its successors, and assigns, and those acting with **the Federation’s** authority and permission, the unrestricted right and permission to use my name, likeness, and biographical material, and that of my co-authors, in connection with the Work, and any derivative or related works, in any and all manner and media throughout the world in perpetuity.

For purposes of this Agreement, the Work is considered to include all material submitted for publication, including, without limitation, the text, figures, tables, author contact details and all supplementary material (*e.g.*, video clips and photographs) accompanying the article, without prejudice to the terms of this Agreement. I hereby represent and warrant that:

_____ All portions of the Work are my (or a co-author's) original creation for which I, or my co-author, have obtained all necessary consents for the use, distribution, and publication of such materials;

_____ I have not granted other parties any rights in or to the Work, which are inconsistent with the rights herein granted to the Federation and I will not submit it for publication, nor is it currently under consideration for publication, elsewhere while it is under consideration by the Federation;

_____ The content of the Work is accurate to the best of my knowledge, does not violate any copyright, proprietary or personal rights of others, and does not contain anything that is defamatory or illegal;

_____ No financial conflict of interest exists with any commercial entity whose products or services are described, reviewed, evaluated or compared in the Work, except for those disclosed under “Acknowledgements” **-OR-**

_____ Either I (including a co-author) or my institution at any time received a payment or services from a third party (government, commercial, private foundation, employer, etc.) for any aspect of the submitted work (including, but not limited to, grants, in-kind support, or other payment or services (data monitoring board, study design, manuscript preparation, statistical analysis, etc.); and/or there are other relationships, affiliations, or activities that readers could perceive to have influenced, or that give the appearance of potentially influencing, the content of the Work. The following is a detailed description of the potential conflict of interest (provide additional attachments if more space is needed):

I hereby indemnify and hold harmless **the Federation**, the Publication Services Provider, and their respective officers, directors, editors, members, employees and agents from and against any and all claims, losses, demands, costs (including reasonable attorneys' fees), and other expenses arising from the inaccuracy or breach of any of the aforementioned representations and warranties.

I understand and acknowledge that **the Federation** undertakes no obligation to publish the Work. If the Work, in whole or in part, or any derivative work prepared therefrom, is published, **the Federation** will acknowledge the contribution of my co-authors and me, but we will receive no compensation and no other benefit with respect to the Work. **The Federation** will return all rights herein granted by my co-authors and me upon written request if the Work is not published within eighteen (18) months of the date of this Author Agreement.

I understand that **the Federation** will give my co-authors and me, through me as corresponding author, the opportunity to read and correct an edited version of the Work prior to publication; provided, however, that if we fail to return our corrections to the Journal editor by the date he or she sets, final editing, production and publication may proceed without our corrections and we will be responsible for any errors.

As the corresponding author of the Work, I have full authority to act on behalf of the other authors in any matter arising from this Author Agreement, including, but not limited to, review and approval of the edited Work.
